World Cooperative Monitor (cont.)



- **Top 300 co-operative and mutual enterprises** in the 2014 Monitor account for **2,205.7 billion USD in turnover.**
- Covering **26 countries**, these top 300 co-ops are mainly involved in the insurance sector (46%), the **agricultural and food sector (27%)** and wholesale and retail trade (20%).
- Based on turnover, the top co-operative in 2012 was **Japanese-based Zenkyoren**, an insurer, with a total output of **77.61 USD billion.**

NEED TO INTEGRATE COOPERATIVES INTO WORLD TRADE STATISTICS



- Review of the different sources suggests that the link between cooperatives and trade is an **under-explored area**.
- **How cooperatives participate in international trade** is not sufficiently addressed by the specialized trade literature.
- **Cooperative-to-cooperative trade is important but data is scarce**; beyond some isolated efforts by the ICA, there seems to be no structured and regular gathering of data.
- **2012, International Year of Cooperatives**, did not sufficiently encourage IOs and other stakeholders to properly assess without ideological bias what the benefits and constraints might be if cooperatives would be seriously included in the current trade & development policies and statistics.

State trading enterprises (WTO)



- Article XVII:1(a)
- The first paragraph of Article XVII refers to three types of enterprises:
 - (i) “State enterprises” (that is, owned by the State);
 - (ii) enterprises granted special privileges by the State (for example a subsidy or subsidy equivalent); and
 - (iii) enterprises granted exclusive privileges (i.e. a monopoly in the production, consumption or trade of certain goods).
- *Work on STEs in the WTO is undertaken mainly by the **Working Party on State Trading Enterprises**.*
